Nicolás Tilli, articulates his research under an interdisciplinary prism (Communication Sciences, Law and Psychology) around two axes: the first concerns the use of communication media for mental health and the second communication for health.

- The use of communication media in the service of mental health invites us to think of the use of communication media (traditional and NICT) as an innovative mediation process (with a clinical component), as an alternative to social inclusion, of occupying public space and different territories, as a means of combating discrimination and stigmatization but also as a vector of communication for social change.
- Communication for health involves analysis and reflection around communication strategies (interpersonal, group, organizational), adapted (from a cultural / intercultural point of view) to the subjects and organizations involved (using different means and supports). Said communication strategies (characteristics of communication for social change) are intended to:
  - think about the different stages of prevention and those of health promotion,
  - influence social representations,
  - propose a co-construction of representations which could be favorable to the improvement of health in different territories,
  - promote equality and social inclusion, and
  - fight discrimination and stigma.

<sup>1</sup> In order to become Maître de conférences (equivalent to a "Tenured Associate Professor"), a PhD holder must obtain from the Conseil national des universités (CNU) a "Qualification", i.e. the insertion on a national list of those qualified for the position of Associate Professor. This can be done through the GALAXIE/ANTARES portal (an online application, only in French). The applicant has time to submit detailed application files (on paper and CD) to the two 'rapporteurs' nominated by the CNU. Once the qualification is obtained (the qualification is valid for 4 year), the candidate applies to the job openings that are offered on the dedicated section of the GALAXIE portal. The Ministry of Education announces most vacant positions of Associate Professor at French universities. However, some universities post jobs also during the year, 'au fil de l'eau' job posting. To fill the vacancies by new recruitments, competitions are being organised at university level. Committees, set up per discipline, are composed of an equal number of Tenured Associate and Full Professors and are re-elected every three years. They select the candidates invited for an interview (usually up to 10 per position). The interviews last 20-30 minutes per candidate, expenses are not covered and the date is not negotiable. Universities cannot contract directly with candidates, hence, the selection committee ranks three to five candidates per position and CNU posts it on the GALAXIE portal. Successful candidates can decide whether or not to accept the job in order of ranking. To become a "Full Professor" the procedure is similar to that of becoming "Associate Professor": one needs to obtain an inscription on the list of people who are qualified for the position of Full Professor before one can apply for vacancies at the universities. To obtain the inscription on the list, the main criterion is to be holder of a

- **Synthesis of the project**: The objectives of this pioneering project are threefold: to create an international consortium (Latin America, the United States and Europe); to promote new and multidisciplinary research (information and communication, law, psychology); and to address an understudied issue in the social and human sciences ("Mental Health on University Campuses") and the population it affects (students and university staff - administrative and teaching).

This multifaceted, multidimensional and multi-sectoral issue requires a multidisciplinary approach to understand its complexity. Thus, this project proposes an efficient and culturally adapted response, based on interdisciplinary and intersectoral management.

The research will be supported by work carried out on university campuses in Toulouse, in collaboration with local agencies (SIMPPS, CHGM, ...) and on the campuses of the partner universities to respond to very current economic, societal and cultural questions related to mental health in universities, which is recognized as a priority by public and international experts.

- **Synthesis of the project:** As the title “Pluridisciplinarity and Art-therapy” states, this project aims to initiate large-scale research into the status and future of art-therapy productions, based on a pluridisciplinary approach, with the collaboration of doctors, jurists, museologists and researchers in the fields of information science and communication. The art-therapy concept refers to artistic productions completed in workshops, with a therapeutic objective and involving a variety of patients. It has been implemented in a wide range of institutions for over 25 years. Arttherapy has seen increasing contemporary development in France, Europe and the rest of the world, integrating diverse situations in terms of practice, organizational methods, location (hospitals, Alzheimer centres, retirement homes, etc.), and the various art fields involved (fine arts, music, theatre, cinema, video, etc.). The institutions involved must now answer questions about organizing, protecting, conserving and exhibiting patients’ artistic productions. Demand can only grow from here, thus confirming public health issues within a society that finds itself in the grip of exponentially developing psychological and psychiatric conditions and an aging population. Given the hodgepodge of situations, the absence of a legal framework (to cover training for art-therapists and the status given to the conserved works) and the absence of evaluative practices for these mechanisms, this research calls for an analysis of the conditions that facilitate these productions, conducted in advance and based on a panel of establishments. Using such an assessment as a starting point, ideas can be put forward about conserving these productions, while identifying selection criteria. The very nature of the concept —as conveyed by the neologism ‘art-therapy’, combining art and science—requires a connection between hard science and human science. Analyzing the status of these productions involves a range of scientific issues that must be dealt with using a pluridisciplinary approach. Issues such as: consent for divulging productions (psychiatric-legal consent); copyright for productions made within a hospital institution (Who is the author? Is it the patient? What about the caregiver’s role, should it be considered a collective work?); exhibition methods (clinical, aesthetic or artistic aspects); and of course the exhibition location (therapeutic environment, contemporary art gallery, outsider art collection) and the very concept of ‘public’ (accepted differently in psychiatric and museological contexts).

- **Ambition:** The aim of this project is to create an art-therapy reference centre in Toulouse, with national and international scope, in line with scientific innovation and responding to far-reaching social issues. It is part of the objective to form a leading research centre, based on site policy consistent with the principle of reconciliation and federation for universities and their research teams. In 2013, this partnership had already organised the congress of the French society for the psychopathology of expression and art-therapy at the Abattoirs museum in Toulouse. The theme of the event, “Create, conserve and protect” served as the premise for this work. This research will be expected to lead to a scientific publication including both parts: the art-therapy report and proposals.

- **Synthesis of the project:** The law n° 26552, on audiovisual services, adopted in Argentina the 10<sup>th</sup> of October of 2009, has opened a new debate on the conditions and processes of democratization of the audiovisual sector. It is pertinent to remark that the Argentine legislation is inspired by the French legislation. Within this context, cultural diversity finds in these legal texts a necessary instrument to lead to its realization in current society. It is precisely this project that has made me discover (since it was necessary to analyze the radiophonic authorizations from the civil society sector...) the Argentine pilot *dispositif* La Colifata, today the subject of my research project. In this way I met Mr. [Alfredo OLIVERA](#) and my interest in pursuing this new field was born.

- **Objectives:** Contextualize the implementation of cultural policy and their legislative promulgation; Study the data tied to the participation of civil society in the legislative debate; Analyze the contours and effects of cultural diversity; Characterize and compare the development of public policies on audiovisual communication in Argentina and France (with a correlative evaluation of the European Union and the Mercosur, respectively); and Shed light on common and divergent aspects of the French and Argentine audiovisual models.
